

Preamble

“We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.” – United States Declaration of Independence.

We, the members of the Australia One Party, in order to form a more perfect nation, establish justice, promote domestic tranquility, equality of race, gender and creed, provide for the defence of our nation, promote its citizens' general welfare and secure the blessings of liberty of all nationals and citizens from conception, do ordain and establish this Interim Draft constitution for the Australia One Party and for Australia and our posterity.

It is charged upon all members of the Australia One Party to uphold these principles for the strength, liberty, protection and sovereign rights of all Australian nationals and citizens, Australia's land, air, waters and domestic and foreign interests now and in perpetuity.

Australia One Party remains independent of any other Party, group, organisation or social agenda.

The Australia One Party ('A1'), its members and representatives affirm and pledge to the people of Australia that we will always remain focused and determined to act for the betterment of all Australians, Australia and her interests as detailed in this, the party's constitution.

Interim Draft Aims and Objectives

The aims and objectives of the Australia One Party are to have an Australian nation that:

- a) upholds, defends and is dedicated to the principles of life, liberty, security and right to the pursuit of happiness of all Australian citizens and residents from conception to death irrespective of race, colour, creed or gender, subject to the unalienable rights of others.
- b) recognises the beneficial role that the Christian world view and its teachings have had in shaping Australia's development as a nation, its legal system and its foundational underpinnings as reflected in its laws.
- c) upholds the Australian Constitution (1901) as the nations' foundation, and recognises its laws and system of national sovereignty acting as a Constitutional Monarchy.
- d) defends Australia and all nationals and citizens, its domestic and foreign interests, its land, sea, and air from:
 - i. physical aggression while playing its part as a world citizen with its allies to maintain peace, as required.

- ii. all persons, organisations and nations who seek domination of or over, the Australian people.
- e) upholds, defends and is dedicated to the principles of freedom of speech, freedom of religion, freedom of association, freedom of assembly, freedom of petition and to protect these from the threat of or actual, violence and suppression, subject to the lawful rights of others;
- f) defends the freedom of the press including but not limited to all taxpayer funded organisations while they adhere to their obligations and limitations as per their agreed Code of Practice and all associated Acts and legislative standards.
- g) is an intelligent, free, and democratic Australian democracy, maintained by:
 - i. an Executive, Legislature and Judiciary as detailed in the Australian Constitution 1901 as it provides for the federation of the States, whereby the Commonwealth government is designed to be a limited, accountable government that serves the States and their peoples.
 - ii. State Governments as detailed in the Australian Constitution 1901 as it provides for their stewardship of and over those areas outside those listed for the Commonwealth government, who serve the people and her interests,
 - iii. an adherence to freedom of speech, freedom of religion, freedom of association, freedom of assembly, freedom of petition speech subject only to the provisions of:
 - A. Libel and defamation
 - B. Incitement to violence
 - C. Sedition
 - D. Treasonand, as determined by an independent judiciary that encompasses trial by a jury of peers, with all Australian citizens, in Australia, being subject only to Australian Law.
 - iv. the freedom of citizens and residents to choose their own way of living and of life, subject to the lawful rights of others.
 - v. the principle that all men, women and children are created equal and independent; that from their equal creation, they derive inherent inalienable rights, among which are the preservation of life, liberty and the pursuit of happiness, subject to the lawful rights of others;
 - vi. the protection of all citizens and residents from exploitation.
 - vii. the right of all citizens and nationals, irrespective of race, colour, creed or gender the right to equal opportunity not equal outcomes.
 - viii. the protection of, development of and use of all its natural resources in a responsible and efficient manner for the benefit of all citizens and residents, while maintaining the natural environment as practicable for the benefit of all Australians.

- ix. the encouragement of citizens and residents and their personal initiative to, and enterprise of, their dynamic force toward progress, subject to the rights of others.
 - x. upholding and maintaining the principles of personal responsibility and accountability of all publicly funded Officials, Departments, officers and their decisions, and making these available to the public on request, provided the security of the nation is not compromised now or in the future; and
 - xi. upholding and defending the Australian National Anthem, the Australian Flag and the Australian Coat of Arms as the only symbols used and recognised by all Government Departments and representatives, citizens, residents and visitors as representing Australia and all Australians irrespective of race, colour, creed, gender or prior national identity;
- h) facilitates its population having access to a comprehensive system of child and adult education designed to develop the spirit of true Australian citizenship, in which no regard to wealth or privilege shall be a determining factor and which:
 - i. has, as its fundamental and enforced priorities the studies of math, English, history, geography, and the sciences.
 - ii. is freely available to all nationals and citizens throughout Australia.
 - iii. is free from bias, ideological influence, racial division, denigration, gender identity coercion or any other ideological fad.
 - i) gives every Australian irrespective of age, the encouragement to develop their inherent and individual talents to their full extent, recognising that from their ranks comes the leadership of our communities and our nation now and in the future.
 - j) promotes and develops industry for the prosperity, security, safety and sovereignty of Australia and all citizens and residents.
 - k) promotes primary, secondary, and tertiary industries, where new markets are developed, where the lot of citizens and residents are improved, rural amenities are increased, and industries are decentralised.
 - l) has a fair and equitable taxation system designed to restore and maintain the conditions outlined in items j) and k).
 - m) promotes and implements laws ensuring the personal safety of Australian citizens, residents and guests, their property and unalienable rights are available to be maintained by the individual in the face of danger, using personal safety resources.
 - n) promotes Australia's sovereign interests in all foreign and domestic affairs, agreements, and exchanges, and to maintain a fair and balanced exchange of terms of trade.
 - o) withdraws from and ceases participation in all international groups, treaties, covenants, and agreements with nations and international organisations that do not respect Australia's right to act in its national interest.

- p) immediately ceases being a party to all agreements with, and the practice of transference of Australian taxpayer funds under the guise of, but not limited to, foreign aid, to any foreign or domestic person, organisation or nation who incites, slanders, defames or promotes the destruction of Australia including but not limited to our people, land, interests, flag or symbols;
- q) protects and enforces the inalienable rights of children (from conception), the traditional family unit and the enforcement of parents' and extended family's responsibilities to children irrespective of race, colour, creed or gender up until and including the age of 18 years old.
- r) enables and promotes a society whereby family life is recognised as fundamental to our nation's well-being, in which:
 - i. every family is enabled to live in, and preferably to own, a comfortable home at reasonable cost,
 - ii. every family shall enjoy and is provided with adequate community amenities and services.
- s) has a manageable and fully efficient immigration policy conducive to the national interest, without regard for colour, sex or race but with the highest regard for the ability and desire to integrate into Australian culture, which includes but is not limited to:
 - i. maintaining a sustainable rate of population growth tied to the infrastructure development required to support said growth.
 - ii. sourcing appropriately educated, skilled and experienced people required to grow and maintain the economy.
 - iii. temporary visa programs for skilled migrants whose employment, medical, housing and education needs are met by the employers; and
 - iv. a refugee program prioritizing registered refugees located in camps or the like throughout the world with priority determined by waiting times and or threat to life due to immediate internal country instability.
- t) has a citizenship system whereby immigrants (legally accepted via the visa system as per item s) becoming citizens are limited to those who:
 - (A) have lived and worked in Australia for not less than ten (10) years,
 - (B) have attained an accepted standard of spoken, read and written English, and
 - (C) have not committed any offence that incurs a custodial sentence during their residence in Australia (as per item t(A)).
 - (D) children of immigrants who have not attained citizenship (as per items t(A)-(C) do not receive Australian citizenship by birth, but rather 'citizenship by descent' of their parents' nation(s) of origin.

- u) affords men and women who have served in the Australian Defence Force, as well as their dependents, respect, honour and security and to whom preferential treatment and generous benefits are owed.
- v) maintains an intimidating defence force with a demonstrated capability to defend Australia and her interests independently by the deployment of a highly destructive offensive sea, land, air, special operations, space, nuclear and cyber capability, coupled with a rapid response time
- w) makes provision for the needs of the aged, the invalided, the widowed, the sick, the unemployed and their dependent children in accordance with Australian law.
- x) provides for adequate medical services to be within the reach of all.
- y) does not permit the nationalisation of any industry or network outside of what is detailed in the Constitution 1901 without the approval of the people by Referendum or as required in the national interest in accordance with and in support of section 4.1 item c), g) I,ii and viii, and j).
- z) has constant employment at good wages available to all willing and able people.
- aa) fosters employers and employees having a sense of common interest and duty, who share as co-operators in all advances of prosperity, and in which living standards rise steadily as physical resources expand and ingenuity grows.
- bb) the protection of Australia's unique flora and fauna as part of Australia's heritage and national identity; and
- cc) in respect of Australian livestock:
 - i. implements a system for the humane slaughter of livestock industry wide, which ensures the animal's quick and painless death via stunning or gassing prior to slaughter, for the Australian and foreign markets, for consumption and or export; and
 - ii. affords no recognition of religious slaughter as an acceptable form of slaughter within Australia or is advocated by Australia unless it accords with section 4.1 item cc (i) above.
